**Site Location:** Coill Dubh/Blackwood, Co. Kildare

**Proposed Development:** Pursuant to the requirements of the above, notice is hereby given by Kildare County Council of a proposed social housing development at Coill Dubh/Blackwood, Co. Kildare. The proposed development comprises the construction of 10 no. Houses consisting of:

1. 3no. three bedroom units.
2. 3no. two bedroom units.
3. 4no. one bedroom units.
4. 10no. garden storage sheds.
5. Vehicular and pedestrian entrance with footpath to the front of the site.
6. Boundary and road improvement works including:
  - a. Removal of part of the boundary hedge at the junction to the L1019.
  - b. Cutting of hedges.
  - c. Pruning existing trees.
  - d. Culvert the existing land drain to the front of the site.
  - e. Proposed new site boundary treatment consisting of masonry walls and railings.
  - f. Undergrounding of existing services.
7. Pedestrian link through the site and an entrance to the adjoining soccer field.
8. Associated site works.
