

**FORM FOR REGISTRATION AS A EUROPEAN ELECTOR**

[section 6 of the European Parliament Elections Act 1997]

**NOTES**

1. This form must be completed by EU citizens living in Ireland who wish to be registered to vote at European elections, other than the following:
  - Irish and British citizens, and
  - EU citizens who were registered to vote in Ireland at European elections since 1994.
2. The completed form should be returned to the county or city council for your area.
3. The information contained in this form will be forwarded to your home Member State to guard against double voting at the election.
4. A person who votes at a European election in Ireland and in another Member State is guilty of an offence and is liable on conviction to a fine not exceeding €3,174.35 or imprisonment for a term not exceeding two years or both.
5. A person who knowingly makes a false or misleading statutory declaration is liable on conviction to the penalty set out for such an offence at the time the offence was committed.

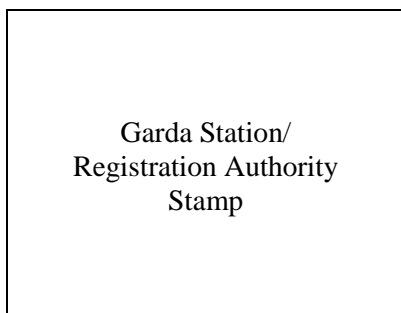
