No. 1—No action was taken in this case as, owing to the adulteration being slight, the Analyst did not issue prosecution form.

No. 2—No proceedings were instituted in this case as the Food and Drugs Inspector

only purchased half a pint of whiskey from the trader instead of three quarters of a pint. The sample sent to the Analyst was, therefore, too small and she was unable to do a complete analysis.

No. 3—In this case the defendant was proceeded against, fined £1 and £1 9s 3d costs at Newbridge District Court on 5th April, 1934.

Departmental Veterinary Inspector visited the farm of Mr. Dunne at Farnadum, Killocock and examined thereon 46 sheep and 33 lambs the property of Mr. J. O'Reilly, 69, Lower Dorset Street, Dublin, and 21 sheep and 32 lambs the property of Mr. Thomas Sammon, Clane. Three sheep and one lamb belonging to Mr. O'Reilly and three sheep belonging to Mr. Sammon were found affected with Sheep Scab. Copies of the detention notices served on Mr. Richardson in respect of Mr. O'Reilly's sheep and on Mr. Sammon in respect of a number of sheep now at Clane which had been in contact with his sheep above-mentioned, which were already under restrictions, will be found enclosed. The Veterinary Inspector for the District should be instructed to deal with these cases under the Provisions of the Sheep Scab (Ireland) Order of 1905.

### COUNTY SURVEYOR'S REPORT.

The County Surveyor's Report as follows was read:—

This is the first payment on road contracts taken from 1st April last for a three year period; for the season of the year under review it is not to be expected that evidence of much surface work on bye roads would be apparent. However, the majority of contractors are known by us to have carried out previous undertakings fairly well, and a good number have already a proportion of the specified metalling carted to the roadside for next winter's repairs.

During the quarter, in all Direct Labour Sections, tar spraying has proceeded in good weather and is now nearly complete. In addition it has been just possible to keep practically all the Council's heavy machinery (seven steam rollers, etc.) at work. It is hoped to continue this when Road Improvement Grants commence, as our own funds from rates would be insufficient for the purpose.

The work of maintenance and cleansing of the several Arterial Drainage Districts as ordered by the Council, including for the first time the newly constituted Griese River District, is now proceeding.

It is unsatisfactory to report that a group of small, but nevertheless important, roads in the vicinity of Kill continue to be over-stressed and damaged by constant heavy extraordinary traffic consisting of the carriage of sand and gravel to Dublin in fast and heavy lorries. It is computed that about 250 tons passes over one of these roads every day, and as the amount provided for maintenance (being approximately the normal rate for many years) is only £13 per mile per annum, it can be easily understood how unsatisfactory this matter has become and also the grievance that exists for the ordinary road user. The lowest cost of thoroughly repairing the damaged surfaces, allowing for the narrowness of those carriage-ways, would be about £500 per mile for light steam-rolling and tar spraying. There are some 10 or 12 miles of road affected and about a similar number of gravel pit proprietors, and if the Council consider the latter should be held liable I should obtain your authority to consult the County Solicitor and make you a further report.

#### CATTLE POISONED.

The following letter was read from Messrs. Brown & McCann:—

Naas,

August 15th, 1934.

Dear Sir,—

We have received instructions from Mr. Thomas Hunter, of Kilgowan, Kilcullen, to communicate with you in the following circumstances:—

Our client is the owner of a farm at Kilgowan aforesaid and has stock grazing thereon. Since October of last year nine of his cattle died as a result of poisoning.

He had one of them opened and examined

by a Veterinary Surgeon recently and his diagnosis was that the animal was poisoned by tar and oil, and the circumstances in which the stock were poisoned are as follows:—

The surface water flows from the public road at Kilgowan into a pond in his field where his cattle graze and are watered at this pond, and we understand that the water which is polluted with tar and oil is diverted into this pond by reason of the fact that your Council raised the road by over three feet and made no alternative exit for the water except into our client's lands, with the result that nine of his stock have died from poisoning.

In these circumstances our client is clearly entitled to be compensated by your Council, but in order to avoid litigation perhaps you would have the matter investigated by your Engineer, and let us hear from you.

Mr. Sargent, B.E., is of course quite competent in every way, but at the same time I do not think it would be desirable that the Council should make payments on the certificate of any person who is not an Officer of the Council.

I presume there will be no difficulty of an arrangement being come to by which the County Surveyor can make arrangements with Mr. Sargent for the latter to supply him with any necessary particulars he may require in order to enable him to issue certificates as the work proceeds.

It will be necessary for a contract to be prepared together with a Bond in connection with the building of the Library, and the Tender should be accepted subject to the Contractor entering into a proper contract and Bond.

## THE PEAT FUEL CO., LTD.

A letter dated 17th September, 1934, was read from the Peat Fuel Company, Ltd., as follows:—

Dear Sir,—

My Company is about to commence the erection of a Peat Briquetting Plant, situated on the Canal Bank, near Ticknevin, Co. Kildare, where it is proposed to produce Peat Briquettes at the rate of 50,000 tons per year. While it is contemplated that a certain portion of this output will have to be transported by Canal it will undoubtedly become necessary to carry considerable quantities of the product manufactured by road to Dublin, in order to avoid rehandling charges which must necessarily occur when the material is transported by canal.

The site for the proposed factory has been selected on account of the road transport facilities offered by its close proximity to the main road leading from Edenderry to Dublin.

One section of this road, however, passes through certain bog areas which are of considerable depth, and these stretches are not in a condition to enable them continuously to carry heavy loads, such as our traffic would impose upon them.

On the assumption that only 50 per cent. of our initial output is carried by lorries to Dublin, this would mean that upwards of 90 tons of briquettes per 24 hours would have to be hauled over this road in motor lorries of large capacity—a duty for which the road in its present condition is not fit. We have had an opportunity of discussing the matter in question with Mr. Rorke, County Surveyor, who appears to be in agreement with our views.

In addition, there exists a short section of road, some 200 to 250 yards in length, which connects the canal bank with the Edenderry-Dublin road, and which would form a connecting link between our factory and that road. This short stretch of by-road is comparatively straight, but very narrow and presumably owing to the fact that it at present only serves to carry supplies to those houses and cottages that are situated on the canal bank opposite our factory site, its surface is naturally far from good, and it would not be possible to utilise this stretch without some considerable widening and re-surfacing operations. My Company would therefore be grateful if your Council would give sympathetic consideration to the rebuilding of such stretches of road in the sections in question, which are at present unfit, with safety, to carry heavy motor lorry transport.

The following letter was read from the County Surveyor on the matter:—  
Ticknevin Peat Fuel Company.

Dear Sir,—

In connection with the letter, copy of which I have received, dated 17th September, from this Company, there are just 3½ miles of the main road in question running over the turf bog through Allenwood, etc., and it would cost £20,000 to lay this in reinforced concrete, which is the only method I can suggest at present to cope with the traffic which has been forecast. The turf in some places under this road is 23 feet deep.

The remainder of the route mentioned is fully 20 miles long in this county, and only consists of ordinary steam rolling tar painted.

It would therefore seem necessary, if the traffic is to be encouraged, that an application be made to expend a large sum of money.

Re Mr. Thos. Hunter, Kilgowan.—Mr Domican's Report.

I met Mr. Thos. Hunter by appointment at his house, Kilgowan. He wants County Council to put a filter bed between his manure depot and the drinking pond in his field. He states that he did not instruct Messrs. Brown & McCann according to contents of their letter. He did not say road was raised by over 3 feet—he might have said by over 3 inches. Surface of road has been raised 2 inches seven years ago, but it did not alter volume or direction of surface water in any way. The fact is that this pond is 7 or 8 feet under road level and a small quantity of water off road has always entered it. For some years past this water together with drainage from Mr. Hunter's premises flows through a manure depot before entering pond.

The attitude Mr. Hunter has adopted leaves it difficult to make any alteration in drainage that might improve matters.

#### ROAD ENCROACHMENT.

The following letter was read from the County Surveyor dated 22nd September, 1934:—

Road Encroachments.

Dear Sir,—

It appears to me that an encroachment of the public road between Newbridge and Kinneagh Cross-roads has taken place by reason of the building of a new residence projecting to the extent of 6 feet approximately outside the wall of the Old Military Barracks, which I assume is the boundary of the road.

As you are probably aware the Board of Works have always claimed certain rights over the ground extending both sides of the road, and the property is, I understand, leased to the Newbridge Town Commissioners.

However, I am unaware that any building line, other than the barrack wall on the same side, has ever been defined, but, nevertheless, permission to build the above-mentioned house apparently has been taken. I understand from the contractor, Mr. Murphy, that his authority was the Town Commissioners.

The Secretary stated that on receipt of the foregoing letter he wrote to Mr. Murphy requesting him to discontinue work pending the meeting of the Council, but he took no notice of the letter.

Building Sites.

Dear Sir,—

I beg to forward you hereunder copy of letter written to me to-day by Senator Cummins, C.T.C.:—

"I would suggest that you and perhaps Mr. O'Connor call on Mr. Coffey and Mr. Rorke in connection with the enclosed letter (letter received by Mr. L. Murphy, contractor, from Mr. Coffey).

"If the County Surveyor will not consent on utilising the plot outside the barrack wall

for the purpose of frontage to buildings then we may abandon the idea of further buildings on that road or on Main Street also.

"I take it that in his present attitude he is only fulfilling his duty to the County Council, as I have no doubt that the necessary sanction of the Council will be forthcoming in due course, but it would be fatal to our plans to hold up the building at present stage.

"If at any time the road requires widening here the Town Commissioners, whose property extends to the middle of the river, will give an undertaking that a corresponding strip of ground on the opposite side of the road can be made available for this purpose.

"Please see Mr. O'Connor and arrange interview with Mr. Rorke and Mr. Coffey."

The interview referred to (with Mr. Osborne) took place from which it appeared that the Town Commissioners are relying on a lease from the Board of Works which proposed to give the Commissioners all the land between the barrack wall and the middle of the River Liffey.

Mr. T. Dunne proposed and Miss Darby seconded—"That no action be taken."

After discussion the proposal was withdrawn.

Mr. Tynan proposed and Mr. Phelan seconded and it was unanimously agreed:—"That the matter be adjourned and that Mr. Osborne be consulted."

#### VETERINARY INSPECTOR.

The Council considered the recommendation of the Finance Committee at meeting on this date with respect to the appointment of a Veterinary Inspector for the Celbridge No. 1 Area as follows:—

#### KILDARE COUNTY COUNCIL.

#### CONDITIONS OF APPOINTMENT OF VETERINARY INSPECTOR—CELBRIDGE AREA.

A qualified Veterinary Inspector for Celbridge Area comprising the late Rural District of Celbridge No. 1 at a salary of £35 per annum under the Diseases of Animals' Acts and £25 per annum under the Bovine Tuberculosis Orders, the latter amount being subject to such alterations from time to time as the Department of Agriculture direct.

Duties:—(a) Attendance at all cases, or suspected cases, of scheduled contagious diseases reported under the respective Orders within the District of the Local Authority Veterinary Inspector, (b) the carrying out of duties under the Diseases of Animals and Orders (including the Bovine Tuberculosis Order and the Sheep Dipping Orders) and of all Orders issued or that may be issued

thereunder by the Local Authority under the Diseases of Animals' Acts, (c) attendance at fairs in the District in connection with the operation of the various Orders, specially the Sheep Scab Orders.

The Inspector when appointed and his appointment sanctioned by the Department of Agriculture shall reside within the above-mentioned area and shall take up his duties forthwith.

Mr. Phelan proposed and Mr. Frayne seconded:—"That the recommendation of the Finance Committee be approved."

Mr. Groome proposed and Mr. Connell seconded:—"That the two Districts of Celbridge No. 1 Area and Edenderry No. 2 be amalgamated and that the existing Veterinary Inspector, Mr. Crowe, be appointed, and that the Minister be asked for his sanction in the matter."

On a show of hands Mr. Groome's proposal was beaten by 13 votes to 11.

Mr. Phelan's proposal was then agreed to without a division.

I am, however, unable to say that permission was obtained for the latter and the position seems to be aggravated by the new obstruction that would be caused at the laneway adjoining for which the County Council have no authority. The matter, of course, will be referred to the County Council at their next meeting, but in the meantime I would suggest that any possible modification in the suggested encroachment would be considered by you, all objection on our part would of course be removed by leaving the existing building line the boundary of the highway."
